Dear President Edwards:

I write to you on behalf of the Local 1105 Election Committee to report on the 1105 election.

In accordance with the Local's By-Laws, a notice of the Election, which included notice of the procedures for nomination, was sent to the membership on August 25, 2017. Nominating petitions were made available to intending candidates beginning September 19, 2017, and continuing through October 10, 2017. All completed nominating petitions were required to be returned to the Election Committee at the Local on or before the close of business October 10, 2017.

On October 11, 2017 the Election Committee reviewed all the completed nominating petitions, which had been returned to the Local. The Election Committee determined that the following candidates were duly nominated:

The Election Committee reviewed the eligibility of each of the above listed candidates. Each is eligible. The Election Committee reviewed the nominating petitions submitted by each candidate. Each petition was properly completed and included the required number of signatures of members in good standing for the office for which the candidate was nominated.

As for the office of President, Secretary/Treasurer, Vice President Northern, Vice President Eastern and two (2) Eastern Business Agents there was not more than one (1) nominated candidate.

Accordingly, there is no contest for those elective positions. The Local's By-Laws provide that, "Whenever there is an unopposed candidate duly nominated for any office or elected position in the Local, such candidate shall be considered elected without the necessity of an election". Article XIV, Section 4(e).

As for the office of Northern Business Agent there were two (2) positions and I received nominating petitions for three (3) candidates. The ballots were mailed on November 9, 2017 and were counted November 27, 2017 the results are as follows:
